DISMISSAL POLICY:

Authorized Parents/Caregivers must sign children out of programs. The only people that your child will be released to are those listed in the "Authorized to Pick Up" area at the end of this form. All Authorized Parents/Caregivers must present ID upon pick up and must be at least 16 years of age.

If there is an emergency and no one on your list can pick up your child, the primary parent/guardian must call the Camp Director to allow another adult to pick up the child or send a signed note of authorization with that person.

CLASS CONDUCT:

battleBLAST Laser Tag and Bricks4Kidz reserve the right to release, without refund of program fees, any child whose behavior becomes unmanageable. This action will not be taken without verbal/written warnings. No children will be allowed to intentionally physically harm any other persons or person's property while class is in session. We highly discourage students from bringing any toys or electronics to camp. battleBLAST Laser Tag and Bricks4Kidz are NOT responsible for damages or loss of any personal property while at a class.

STAFF:
